Dear Mike and Pat:

On behalf of the Secretary of Commerce, we approved Amendment 21 to the Summer Flounder, Scup, and Black Sea Bass Fishery Management Plan (FMP), including all the management measures recommended by the Council in this amendment. Amendment 21 revises the state-bystate allocations of summer flounder when the coastwide quota exceeds 9.55 million lb and updates the FMP goals and objectives specific to summer flounder. We expect to publish a final rule implementing allocation changes by the end of 2020. Publication in 2020 will enable us to apply the allocation changes to the 2021 specifications.

## State-by-State Allocations

Amendment 21 changes the state-by-state commercial quota allocations when the coastwide quota exceeds 9.55 million lb. When the coastwide quota is 9.55 million lb or less, the quota will be distributed according to the baseline allocations. In years when the coastwide quota exceeds 9.55 million lb, any additional quota beyond this threshold will be distributed in equal shares to all states except Maine, Delaware, and New Hampshire, which would split 1 percent of the additional quota. The 9.55-million-lb threshold reflects a combined 10-year (2009-2018) and 5-year (2014-2018) average of commercial summer flounder quotas. The Council and Summer Flounder Board selected this allocation alternative to balance preservation of historical state access and infrastructure at recent quota levels, with an intent of providing equitability among states when the stock and quota are at high levels.
