I. Mid-Atlantic Fisheries Enforcement and Marine Protected Species Operations

Operations Summary

During this period, major cutters, patrol boats and stations conducted fisheries patrols in the Mid-Atlantic in an effort to curtail illegal fishing throughout D5's AOR. Throughout this period, units conducted 102 boardings and issued nine notices of violation. CGC LAWRENCE LAWSON was commissioned in Cape May, NJ. CGCs NANTUCKET and CUSHING were decommissioned in Ft. Macon, NC.

14FEB17: CGC NANTUCKET issued a fishery violation to a commercial fishing vessel for illegally fishing in a prohibited area.

22FEB17: CGC HERON issued a fishery violation to a commercial fishing vessel for gear not being in compliance with the Atlantic Large Whale Take Reduction Plan.

23FEB17: STA Cape May issued a fishery violation to a commercial fishing vessel for fishing with undersized mesh.

23FEB17: CGC CAMPBELL issued a fishery violation to a commercial fishing vessel for an expired Operator's Permit.

06MAR17: CGC BEAR issued a fishery violation to a commercial fishing vessel for zip-tying escape vents on their traps.

06MAR17: CGC BEAR issued a fishery violation to a commercial fishing vessel for an improper VMS code.

06MAR17: CGC FLYINGFISH issued a fishery violation to a commercial fishing vessel for not having an operator's permit onboard.

26MAR17: STA OREGON INLET issued a fishery violation to a recreational vessel for having a trophy bluefin tuna (93-in) onboard during the recreational closure.

29MAR17: CGC COCHITO issued a fishery violation to a commercial fishing vessel for not having an operator's permit. This is the second time within one year that vessel did not have an operator's permit.
