Move that the Council intends to allow for modification of at-sea observation measures through the specifications process, particularly those alternatives described in alternative set 3 of Amendment 14.

Move to recommend to NMFS 5b4, i.e., 100% coverage for MWT mackerel trips as the preferred alternative in Amendment 14. McMurray/Anderson (14/3/1)

Motion carries

Move to amend to recommend to NMFS that 100% observer coverage is set for the MWT mackerel fishery and that this level of coverage is necessary for the conservation and management of shad, to accurately assess all catch, and to implement measures to minimize bycatch and/or incidental catch of river herring and shad and other managed species. Zeman/no second

Move to recommend to NMFS 5c4, 100% coverage for SMBT mackerel trips as the preferred alternative in Amendment 14. From Committee

Move to recommend to NMFS that 25% coverage would be applied for Tier 3 and 50% coverage for Tier 2 and 100% coverage in Tier 1 for the SMWT fishery for vessels to land over 20,000 pounds.
