Subject: Inflation Reduction Act Funding – Mid-Atlantic Council Project Proposals

As part of the Inflation Reduction Act (IRA) passed by Congress in 2022, \$20 million was made available to the regional councils to support the development and advancement of "climate-related fisheries management and implementation efforts." NOAA Fisheries established two project proposal opportunities to distribute these funds to the councils. The first opportunity allocated \$375, 000 to each council and grant applications detailing project proposals to be supported with this initial round of funds were due by December 31, 2023. The second funding opportunity would allocate the remaining \$17million, up to a maximum of \$3.5 million to any one council, based on a competitive project proposal evaluation and ranking process with project proposals due by January 31, 2024.

On December 18, 2023, the Mid-Atlantic Council (Council) submitted the initial grant application which included detailed project descriptions, anticipated activities, and budget breakdowns for the two projects to be supported by the \$375,000. Those two projects included:

- 1. An Operational Forecast to Reduce Bycatch of River Herring in the Mid-Water Trawl Fishery. Total project costs \$258,022
- 2. Collaborative Strategies to Adapt Scup Gear Restricted Areas (GRAs) to Changing Ocean Conditions. Total project costs \$116,978

The Council submitted the secondary grant application on January 31, 2024 which included six project proposals that will evaluate changes to the existing management and governance framework and increase the Council's adaptive capacity to respond and adapt to a changing climate (Table 1). These proposals, totaling \$2.125 million, are large, cross-Council initiatives that will involve engagement and input from management partners, science experts, and stakeholders to ensure greater support and successful outcomes.

NOAA Fisheries has indicated that funds associated with projects supported by the initial \$375,00 should be available by late February/early March 2024. Funds for approved projects as part of the secondary funding opportunity should be available in late spring/early summer (April/May) of 2024.
